(the "Company") announces that on December 5th 2017 it was notified of Resolution No. 830/17 passed by the Management Board of the Central Securities Depository of Poland ("CSDP") on December 5th 2017, under which the CSDP Management Board resolved to register, as of December 7th 2017, 42,500,000 (forty-two million and five hundred thousand) allotment certificates for Series K ordinary bearer shares, with a par value of PLN 2 (two złoty) per share, in the depository of securities maintained by the CSDP and to assign them code PLRAFAK00091.
