

## CURRENT REPORT FILED WITH THE POLISH FINANCIAL SUPERVISION AUTHORITY IN WARSAW DATE: February 2nd 2023

## Subject: Jaworzno project update – further extension of deadline set for TAURON Wytwarzanie S.A. to comply with notice to provide payment guarantee [Current Report 8/2023]

## Text of the report:

The Management Board of RAFAKO S.A. of Racibórz (the "Company") announces - further to the Company's Current Reports: (i) No. 88/2022 of December 15th 2022 announcing that on the same day a notice was given, within the meaning of Art. 649<sup>3</sup>.1 of the Polish Civil Code in connection with Contract No. 2013/0928/Ri for the development of new coal-fired generation capacities at TAURON Wytwarzanie S.A. - construction of a 910 MW supercritical power generation unit at the Jaworzno III Power Plant – Power Plant II: steam boiler, turbine generator set, main building, electrical and I&C systems (the "Contract"), the parties to which were the Company and Mostostal Warszawa S.A. of Warsaw ("Mostostal"; with the Company and Mostostal jointly referred to as the "Contractor") as the Contractor and TAURON Wytwarzanie S.A. of Jaworzno ("TAURON Wytwarzanie") as the Employer, by the Contractor to TAURON Wytwarzanie to provide a payment guarantee within the meaning of Art. 649<sup>1</sup> of the Polish Civil Code for the remuneration due to the Contractor under the Contract (the "Notice"), and (ii) No. 7/2023 of January 26th 2023 announcing that January 26th 2023 the Contractor submitted a statement to TAURON Wytwarzanie notifying it of an extension until February 3rd 2023 of the deadline originally stated in the Notice for TAURON Wytwarzanie to comply with the Notice - that on February 2nd 2023 the Contractor submitted a statement to TAURON Wytwarzanie notifying it of a further extension – until February 9th 2023 – of the deadline originally stated in the Notice for TAURON Wytwarzanie to comply with the Notice.
